**Cancellation Policy:** For cancellations made more than seventy-two (72) hours of schedule arrival, the member will be charged a processing fee of Thirty-Five Dollars (\$35) per reservation. For cancellations made within seventy-two (72) hours of schedule arrival, the member will be charge for one night's lodging (room and tax). No-shows, early departures and/or late arrivals are non-refundable.

**Tax Exempt Status** – In order to receive tax exempt status, the tax exempt certificate and tax exempt affidavit must be received 30 days prior to group arrival. Individuals responsible for their own accommodation will need to present a copy of their tax exempt certificate upon arrival, and pay with a company check or credit card.
